**BETWEEN:**

**DEFINITIONS**

In this Agreement, unless the context otherwise requires, the following expressions have the following meanings:

- "Confidential Information"** Means information which is disclosed to the Sub-Contractor by the Contractor pursuant to or in connection with this Agreement (whether orally or in writing or any other medium, and whether or not the information is expressly stated to be confidential or marked as such) including in particular the identity or any information whatsoever relating to the Contractor's clients to whom the Massage Therapy is provided including without limitation the location or nature of the said client's premises;
- "Controller"** shall have the meaning assigned in the Data Protection Laws;
- "Data Protection Legislation"** means all applicable legislation in force from time to time in the United Kingdom applicable to data protection and privacy including, but not limited to, the UK GDPR (the retained EU law version of the General Data Protection Regulation ((EU) 2016/679), as it forms part of the law of England and Wales, Scotland, and Northern Ireland by virtue of section 3 of the European Union (Withdrawal) Act 2018); the Data Protection Act 2018 (and regulations made thereunder); and the Privacy and Electronic Communications Regulations 2003 as amended;

- "Party"** means either party to this Agreement and "Parties" means both of the parties to this Agreement.
- "Supervisory Authority"** means any regulatory, supervisory, governmental or other competent authority with jurisdiction or oversight over the Data Protection Laws;
- "Substitute Therapist"** means any person, either self-employed or employed by the Sub-Contractor, with suitable skill, knowledge and experience, who is nominated and engaged by the Sub-Contractor to carry out any or all Massage Therapy on the Sub-Contractor's behalf;

The headings in this Agreement are for reference purposes only and shall not be incorporated into this Agreement.

In this Agreement, unless the context otherwise requires, words in the singular include the plural and vice versa, words importing any gender include any gender, and a reference to a person includes a reference to a body corporate and to an unincorporated body of persons.

**IT IS AGREED** as follows:

- 1. **ENGAGEMENT OF SUB-CONTRACTOR**
  - 1.1 The Contractor hereby engages the Sub-Contractor for a period of one year from the date hereof (the "Term") to provide massage therapy services to the Contractor's clients as laid out in the attached Schedule (the "Massage Therapy"), in accordance with the terms and conditions of this Agreement.
  - 1.2 The Term shall renew automatically upon expiry for further period of one year and shall continue to do so indefinitely in the event that neither Party has given notice of their wish to terminate as provided under Clause 7 hereof.
  - 1.3 The Sub-Contractor may at their complete discretion, at their own expense, substitute any Substitute Therapist for themselves at any time (and on one or more occasions) to carry out some or all of the Massage Therapy. The Sub-Contractor shall use reasonable endeavours to consult with the Contractor beforehand about any such substitution in any case but the Sub-Contractor shall not be obligated to consult the Contractor or to accede to any request by the Contractor to engage the Sub-Contractor or any Substitute Therapist. The Sub-Contractor shall in any event provide such a substitute where the provision of the Massage Therapy is unduly delayed by absence due to incapacity, or for any other reason upon notification by a duly authorised representative of the Contractor that the delay occasioned is unacceptable. The Contractor shall only be entitled to refuse to accept any Substitute Therapist (whether or not consulted by the Sub-Contractor) if in its reasonable opinion they are not suitable due to lack of requisite skills.
  - 1.4 It is understood and agreed that the Sub-Contractor's activities and working methods and those of any Substitute Therapists are at all times exclusively for the Sub-Contractor to determine, supervise, direct and control provided they conform to the specifications contained at Schedule 1 hereof. The Contractor shall not seek to supervise, direct or control the Sub-Contractor or any Substitute Therapists in the provision of the Massage Therapy, nor shall the Contractor have any right to do so.
  - 1.5 The Sub-Contractor shall be exclusively responsible for organising, and is

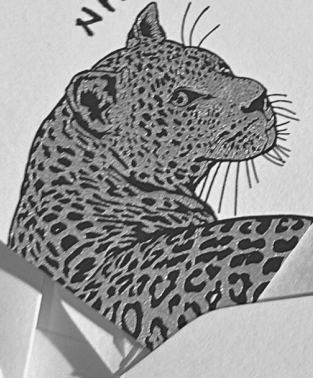
